

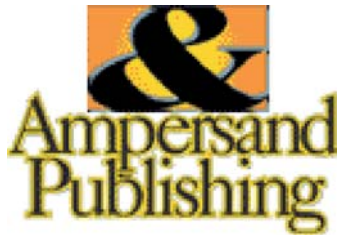


Dear Adam:
